

CONSENT TO PERSONAL DATA PROCESSING AND INFORMATION ON PERSONAL DATA PROCESSING

BASIC SUMMARY

You hereby grant your consent to processing of your personal data to VSHosting s.r.o. for the purposes of communication regarding your inquiry or requirement. Your personal data will not be used for marketing purposes. You can revoke your consent at any time and the personal data processing will be terminated. You can find detailed information on the processing of your personal data below.

1. IDENTITY AND CONTACT DETAILS OF THE CONTROLLER

- 1.1. The Controller of your personal data is VSHosting s.r.o., with its registered office at Sodomkova 1579/5, Hostivař, 102 00 Prague 10, Id. No.: 615 05 455, registered in the Commercial Register kept by the Municipal Court in Prague, Section C, File 29746 (hereinafter the “**Controller**”).

- 1.3. The Controller did not appoint a data protection officer.

2. LEGAL BASIS FOR PERSONAL DATA PROCESSING

- 2.1. The legal basis for the processing of your personal data is formed by your consent hereby granted to the Controller within the meaning of Art. 6 (1)(a) of Regulation 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter the “**Regulation**”).

3. PURPOSE OF PERSONAL DATA PROCESSING

- 3.1. Your personal data are processed for the purposes of communication between you and the Controller regarding your inquiry or requirement.
- 3.2. The Controller does not use automated individual decision-making within the meaning of Article 22 of the Regulation.

4. PERIOD OF STORAGE OF PERSONAL DATA

- 4.1. Your personal data will be stored by the Controller for the period of 5 years from the granting of your consent to the processing for this purpose, however, not longer than until you revoke your consent to the processing of your personal data for the relevant purpose of processing.

5. OTHER RECIPIENTS OF PERSONAL DATA

- 5.1. Other recipients of your personal data may be persons ensuring technical, organisational or commercial activities related to operation of the Controller’s websites or applications, in accordance with the Controller’s instructions (personal data processors).
- 5.2. The Controller does not intend to transfer your personal data to a third country (outside

EU) or to an international organisation.

6. RIGHTS OF THE DATA SUBJECT

- 6.1. Under the terms and conditions stipulated in the Regulation, you have the right to request from the Controller access to your personal data, the right to rectification or erasure of your personal data or restriction of their processing, as well as the right to data portability.
- 6.2. You have the right to revoke consent to the processing of your personal data granted to the Controller at any time. However, this shall in no way prejudice the lawfulness of the processing of your personal data performed prior to the withdrawal of the consent. - 6.3. If you think that the processing of your personal data violated or violates the Regulation, you have also the right to lodge a complaint with a supervisory authority.
- 6.4. You are not obliged to provide personal data. Providing your personal data is not a legal or contractual requirement, nor is it a necessary requirement for the conclusion of a contract.
